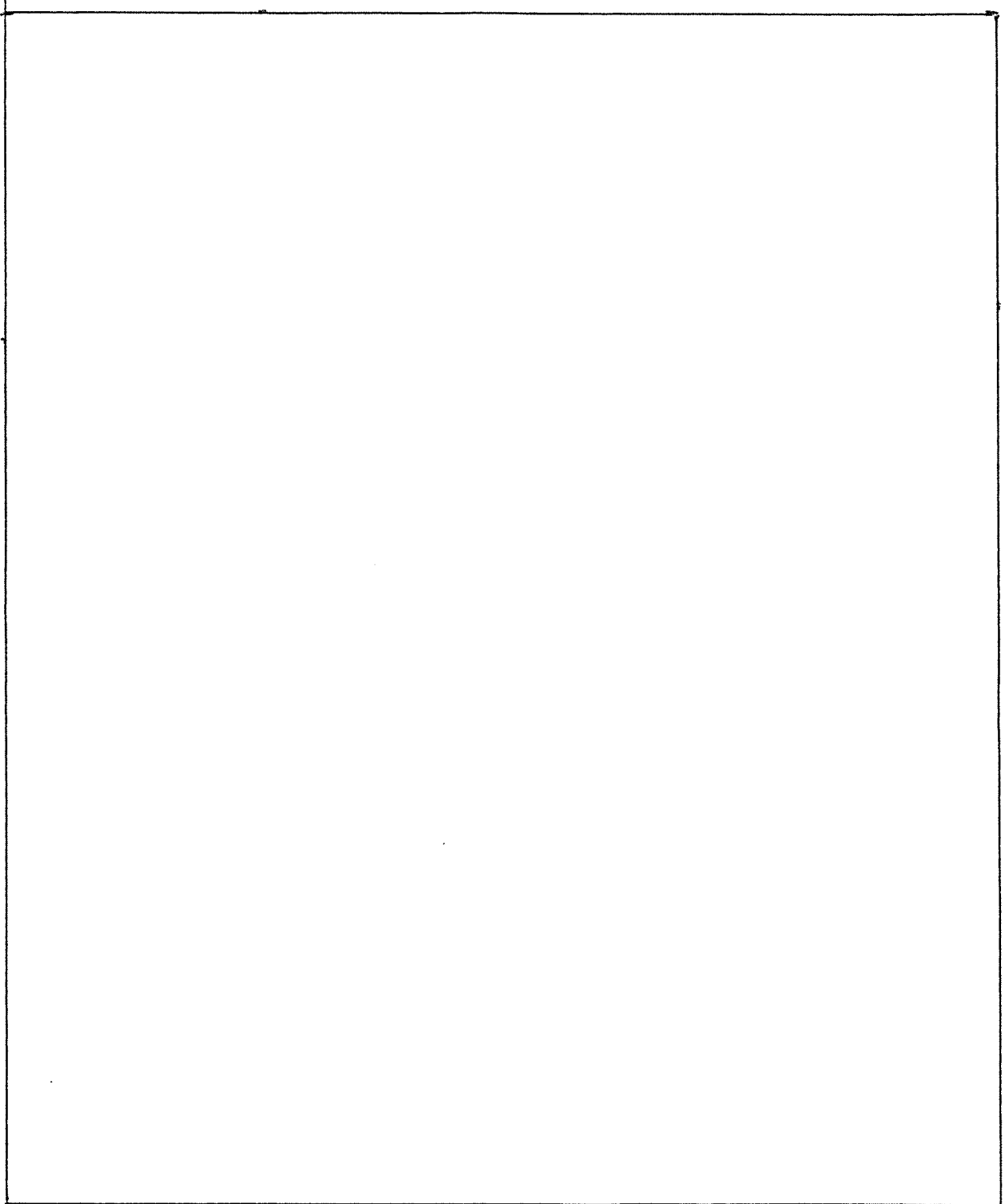

By accepting a license issued pursuant to this Ordinance, the licensee waives and releases the Town of Greene, its officers, elected officials, employees, attorneys and agents from any liability for injuries, damages, or liabilities of any kind that result from any arrest or prosecution of any recreational marijuana establishment owners, operators, employees, clients or customers for a violation of local, state or federal laws, rules or regulations. All licensees, jointly and severally if more than one agree to indemnify, defend and hold harmless the Town of Greene, its officers, elected officials, employees, attorneys, agents and insurers against all liability, claims, and demands on account of any injury, loss or damage, including without limitation, claims arising from bodily injury, personal injury, sickness, disease, death, property loss or damage, or any other loss of any kind whatsoever arising out of or in any manner connected with the operation of a licensed recreational marijuana establishment.
